**Road Maintenance:**

- Discussed redoing approximately one mile on either Albany C or D. After a unanimous decision, Mark made a motion to approve redoing 1 mile of D and Mike seconded it. Corey will replace the 2 culverts in the road to reduce the cost.
- The roadway over the culvert on Albany L West needs to be lowered. Mark made a motion to redo approximately a 50-75 foot section over the culvert and Mike seconded it.
- Pepin County will take an inventory of the culverts in the township.

**Public Comment:**

- Linda and Greg Forsythe discussed turning Albany IH from a town road into their private driveway. It is about ¼ mile in length. Julie will call the Towns Association to find out the appropriate steps to take and let the Forsyth's know what they need to do. It will be added to the agenda for next month.
- Corey Brantner said that Eli Borntregor on Albany N put up a fence in the road right of way. This needs to be removed. Julie will send a letter.
- Mike discussed information he learned from attending the Wisconsin Town's Association meeting regarding fires in the roadside. The maximum the County would pay towards a fire would be \$200.00 and the Town is unable to pass a ruling on it.
- Ben Gibault brought up placing cameras around the town hall area to keep an eye on the dumpsters and dog complaints. They are relatively inexpensive and could be helpful with the issues.
- There was discussion regarding the dog issue around the townhall. Trevor Rud will be contacted about the problem.
- Mike brought up information about the Open Book/Board of Review regarding the personal property issue.
